- That, I am Authroised of Chhattisgarh Yuva Vikas Sangathan sponsoring Vipra Kala, Vanijya Avam Sharirik Shiksha Mahavidyalaya, G.E. Road, Raipur (C.G.) for conducting D.El.Ed. and M.Ed. course. The proposed Institution is not conducting any non-teacher education course. Presently the institution is conducting two units of B.Ed., One B.P.Ed and one unit M.P.Ed. course.
- 2. That, on 20/04/2017, the visiting team of WRC, NCTE, Bhopal had conducted the inspection of the proposed institution at Vipra Kala, Vanijya Avam Sharirik Shiksha Mahavidyalaya, Behind Pt. That, the land use of the institutional plot was permitted to be changed to "Educational Use" vide orders of Collector Diverson Raipur dated 10/02/2003 The institutional building was constructed by the society on this very plot strictly in accordance with the building plan approved by Town Planner Nagar Palik Nigam , Raipur, C.G. vide orders dated 14-22/04/2003,111-8/06/2004,400-31/03/2011,341-22/04/2003. The construction of Institutional building was completed on this very plot on 20/03/2003 and 31/03/2014 vide completion certificate dated 146-28/12/2010 and 211-18/04/2017.
- That, the institutional plot was well demarcated by raising boundarywalls/bacbed-wire-fencing on all four sides. The main gate of the institution is on Eastern/Western/Northern/Southern side which is well connected to G.E. Road N.H.6 through a barrier free approach road.
- 5. That, I do hereby certify that the visiting team had conducted the inspection of the proposed institution on that address which the society had given in the application for recognition. I hereby declare that the WRC, NCTE Bhopal may prosecute me and other office bearers of the society for fraud and cheating in Bhopal Court if it is detected in future that the visiting team was misled and made to submit the inspection report concerning any other institutional building except the institution situated on the address mentioned in paragraph 1 of this affidavit.
